27 28 29	3.	The period of voting shall be at least ten (10) days, beginning, no later than four (4) weeks after the announcement of the slate.

Each Representative when voting shall indicate a rank order preference for each candidate for each position. b. Ballots shall be counted in accordance with the voters' preferences until a majority vote for each office is attained. c. There shall be no reballoting for any position. d. The process for voting and ballot counting shall be explained in the voting materials for each election.
